

## QLD Resident Letting Agents Licence

This course will give you the necessary educational requirements needed for application to QLD Fair Trading. A resident letting agent is defined as a person or company collecting rent, managing property on behalf of clients within a residential complex and marketing the complex as a whole. A licensed resident letting agent may perform these activities in the carrying on of a business, either alone or with others, or as an employee of someone else.

### The following modules must be completed

BSBSMB406	Manage small business finances
CPPDSM4006A	Establish and manage agency trust accounts
CPPDSM4007A	Identify legal and ethical requirements of property management to complete agency work
CPPDSM4010A	Lease property
CPPDSM4015B	Minimise agency and consumer risk
CPPDSM4016A	Monitor and manage lease or tenancy agreement
